**GUIDELINES FOR FINANCIAL ASSISTANCE UNDER ECONOMIC SUPPORT
SCHEME OF TELANGANA STATE MINORITIES FINANCE CORPORATION
HYDERABAD**

Revised Guidelines Under Economic Support Scheme for sanction of Financial Assistance of Rs.1.00 lakh as 100% Subsidy / grant for each beneficiary during 2023-24, with respect to minority applicants who have applied online during 2022-23 through OBMMS, but not sanctioned may subsidy loan as on 15.06.2023 can be considered in the financial year 2023-24.

Aims and objectives of the Scheme

- To aid, assist, promote, encourage, develop and extend financial assistance by way of Subsidy to the financially and socially weaker and needy and eligible members of Minority Communities (Muslims, Buddhists, Sikhs, Jains and Parsis) in the State of Telangana.
- To promote economic developmental activities for the benefit of weaker sections amongst the Minorities with a view to secure their social betterment and general upliftment and to improve their means and standard of living.

- iii) Max. Unit Cost : Rs.1.00 lakh per unit
- iv) Subsidy : 100% of Rs.1.00 lakh per unit

**IV. Procedure for sanction of 100% Subsidy with respect to pending
online cases of 2022-23**

Pending online applications in OBMMS under Category I & II shall be converted and moved to the concerned DMWOs Login in OBMMS by CGG - for sanction of 100% Subsidy of Rs.1.00 lakh per unit viz; Annexure - I as per District wise Population allocation & Annexure - II as per Constituency wise allocation.

c) District wise allocation :

- i) The concerned DMWO have already processed the pending cases which were selected as per District wise population allocation during 2022-23 from DMWO's login and obtain the approval of the concerned District Collector for sanction of 100% Subsidy of Rs.1.00 lakh per unit as per Annexure -I 10,000 numbers.
- ii) The DMWO shall upload the approved list of beneficiaries in VC & MD Login for sanction of 100% Subsidy of Rs.1.00 lakh per unit.
- iii) The VC &MD shall sanction and release the Subsidy @ Rs.1.00 Lakh per unit to the eligible beneficiaries as 100% direct Subsidy to the Joint Account of the concerned District Collector and the DMWO .
- iv) The DMWO shall prepare 100% Subsidy Cheques for Rs.1.00 lakh (in favour of the beneficiary/s) and disburse the cheques to the selected list of beneficiaries under proper acknowledgement by organizing Distribution program in consultation with the District Collector in the presence of Hon'ble District incharge Minister / Public Representatives as per the schedule decided by the District Collector and the Public Representatives.
- v) The DMWO shall Ground the scheme and submit the UCs immediately to the VC & MD, H.O and upload the UCs along with still photograph of the units grounded in the OBMMS Webportal.

d) Constituency wise allocation

- i) The concerned DMWO shall obtain pending eligible online applications of 2022-23 through the concerned MLAs/Public Representatives from all the Constituencies in the District as per the targets enclosed at Annexure - II
- ii) The DMWO shall verify and scrutinize the eligible applications received through the concerned Hon'ble MLAs/Public Representatives, and submit the eligible list of pending online applications of 2022-23 @ 120 Units from each Constituency to the concerned District level Selection Committee for verification and approval.
- iii) The DMWO shall ensure to check any duplication of applications which were selected during 2022-23.
- iv) The total approved list of beneficiaries @ 120 per Constituency shall be forwarded to the VC & MD login by the DMWO for sanction of 100% direct Subsidy of Rs.1.00 lakh per candidate .
- v) The VC &MD shall sanction and release the Subsidy @ Rs.1,00,000/- per unit to the eligible beneficiaries as 100% direct Subsidy to the Joint Account of the concerned District Collector and the DMWO .
- vi) The DMWO shall distribute the 100% Subsidy Cheques of Rs.1.00 lakh per unit (issued in favour of the beneficiary/s) to the selected list of beneficiaries under proper acknowledgement by organizing Distribution program in consultation with the District Collector in the presence of Public Representatives as per the schedule decided by the District Collector and the Public Representatives.

- vii) The DMWO shall Ground the scheme and submit the UCs immediately to the VC & MD, H.O and upload the UCs along with still photograph of the units grounded in the OBMMS Web portal.

VI. Eligibility Criteria under Financial Assistance

- xii) Applicant should belong to Minority Community viz: Muslim, Sikh, Buddhist, Parsi & Jain.
- xiii) Aadhaar Card and Ration Card / Food Security Card of the applicant as address proof (Mandatory) should be enclosed.
- xiv) Preference shall be given to Women applicants to cover a minimum of 33 1/3 % of the total target for the District.
- xv) 5% reservation for persons with bench mark Disabilities with Priority to Women with bench mark Disabilities, shall be allocated out of the total target for the District / Constituency.
(as per G.O.Ms.No.1, Deptt. for Women, Children, Disabled & Senior Citizen, dated 16-01-2018).
- xvi) The DMWO shall ensure that the applicant should not have got any other benefit under Economic Support Scheme of the TSMFC.
- xvii) The grant will be given to only one Member from a family.
- xviii) The individual age limit fixed for applicants is from 21 years to 55 years as on 2nd June, 2023.
- xix) The annual income of applicant shall not exceed Rs.1.50 lakhs in Rural areas and Rs.2.00 lakhs in Urban areas.
- xx) The selection process shall be completed by the District Level Monitoring Committee/District Level Screening cum selection committee headed by District Collector. The District Collector shall take the approval of District Incharge Minister for the District as a whole for this Scheme.
- xxi) Selection list (Phase wise) has to be displayed in TSMFC website.
- xxii) The subsidy will be released as a onetime grant.

The DMWO's shall be responsible to ensure there is no duplication of names.
